4. Updates and bug fixes



Installation

You can install this version as a new installation or as an update. Run the OtoAccess.exe file from the installation package and follow the installation guide.

Important: To ensure compatibility in a server/client setup, all OtoAccess Database installations must be updated to version 2.4. Please note that previous versions of OtoAccess Database will not be compatible with version 2.4 due to database updates. For more information, please refer to the installation package.

To upgrade, please uninstall the existing OtoAccess® Database in Windows Settings – Apps or add/remove programs. <u>Patient and measurement data will not be deleted.</u>

Important: When running the installer, select 'use existing database' to keep patient and test data.

Already activated OtoAccess® Database licenses remain active after the update.

It is recommended to make a manual database backup from the OtoAccess® Database Administration tool and/or ensure that your automatic database backup is valid before upgrading.
